This application form will only be complete if it is accompanied by a copy of the bank transfer with the **TRN showing payment of the entry fee**. In any case, registration will be completed with actual crediting on the current account of Porsche Italia S.p.A.

In the event that Porsche Italia S.p.A. refuses registration, the fees paid will be refunded.

This form must be sent in advance to Porsche Italia S.p.A. by e-mail (specific contact details indicated in Article A.10.1 of the Sport Regulations 2021) **by the Friday prior to the Pre-Race Test**. Entries received after this date will be considered by the organisation if properly substantiated.

By signing this document, the Racing Team, the Driver and the Owner of the vehicle expressly declare that they have examined and accepted the Technical and Sport Regulations 2021 of the Porsche Carrera Cup Italy, the Supplementary Regulations and the general C.S.A.I. rules, including the annexes, and that they will scrupulously comply with that provided for therein.

## General declarations by Racing Teams and Drivers

The Racing Team/Driver declares that the information contained in this form is correct and complete, that the driver holds a licence with the **minimum required grade of C National Senior or C International** (ref. Art. A9 of the Sport Regulations) and has knowledge of the rules and regulations governing track motor racing.

The Racing Team also certifies that the vehicle complies with the specific technical characteristics described in the Technical Regulations of the Porsche Carrera Cup Italy 2021 Championship, that it will be prepared in compliance with the Technical Regulations and that it will be set up at all times during the weekend in perfect technical and aesthetic conditions.

With the signatures at the bottom, Racing Team/Driver expressly declare:

- That they have read the General Regulations issued by FIA and by the other sport authorities linked to it, all the Annexes and above all the ISC articles/ISC Annexes referred to in the various parts of the Sport and Technical Regulations of the Porsche Carrera Cup Italy 2021. - That they have read the National Sport Regulations and the other rules contained in the CSAI Yearbook 2021 and its annexes, see, in particular, the R.D.S. V.C. concerning track speed competitions.
- That they consider the aforesaid Regulations, together with the Sport and Technical Regulations of the Carrera Cup Italy Championship, as binding rules to refer to, and therefore that they strictly comply with them.
- That the Technical and Sport Commissioners present at the various tracks, together with the Clerk of the Course and other CSAI Officials, have the power to impose penalties and fines in the event of failure to comply with the above regulations.
- That the Racing Team, for the duration of the sport weekend, is held liable for any action resulting from a member of the team (mechanics, engineers and other personnel involved) behaving in a way that is detrimental or contrary to the rules of conduct laid down in the aforementioned regulations.
- That the Driver is held liable for any damage resulting from harmful conduct and/or conduct in contrast with the rules laid down in the above-mentioned regulations accepted by said Driver, inside and outside the track, for the entire duration of the sport weekend.

**Declarations of liability of Racing Teams and Drivers**

Competitors and drivers participate in the sport event at their own risk. They therefore accept administrative, civil and criminal liability for any damage caused directly or indirectly also by the vehicle they drive to third parties or third-party property.

By signing this document, the Racing Team/Driver declare that they release and hold harmless the following parties from any liability, damage to property and/or people:

- Porsche AG, its representatives, sponsors and suppliers;
- Porsche Italia S.p.A., its representatives, sponsors and suppliers;
- FIA, CSAI, their delegates and representatives;
- ACI ITALIA, ACI Sport, all companies associated with them, their delegates and representatives, including the Technical and Sport Commissioners, and the Clerk of the Course;
- Race tracks, their owners and representatives;
- The persons in charge of providing Track Services, and all persons involved in the organisation of the sport weekend;

The above limitations shall not apply in the case of damage of intentional or malicious origin, or caused by gross negligence.
