

Porsche Carrera Cup Italia 2024 Sustainable Management | Team Guidelines

Foreword

With reference to Porsche Italia's commitment to the sustainable management of the Porsche Carrera Cup Italia, in compliance with the international standard ISO 20121 - Sustainable Event Management, the following guideline is intended to provide the Teams with the main instructions and recommendations to **improve the environmental, social and economic impact** of their participation, both at the host circuit and at their operational headquarters.

Also for the 2024 edition, the "**Sustainability Officer**," which was introduced to the Porsche staff during the 2023 edition, is responsible for providing guidance and support to the teams in order to develop their awareness of sustainable development and compliance with the principles contained in this guideline, as well as the primary contact person for any need for clarification and discussion for possible improvements.

The Sustainability Officer is also responsible for monitoring and ensuring compliance with the provisions and recommendations of the guideline and any resulting actions (see section D-Warning System).

This guideline does not replace national legal provisions, nor the Regulations of Porsche Italia, ACI SPORT and the host circuits.

A. Before the event

Information and training

The Team must ensure that all its staff members are informed and aware of the significance of **sustainable development** and, specifically, how the Team can contribute to the sustainable management of the PCCI.













To minimize the risk of a pollutant incident, the team must ensure that all members of its staff know the **environmental risks** associated with their work activities and what **control measures** should be implemented to prevent, reduce, or eliminate the negative impact. Each team member must be able to recognize any actual and potential critical situation so that it can be addressed and immediately reported to Porsche Italia, which in turn can implement appropriate corrective measures in agreement with the organizing circuit.

Workers' health and safety

Teams must comply with legal requirements related to workers' health and safety, as well as comply with applicable national environmental laws.

Travel arrangements, logistics and transportation

Whenever the team organizes a transfer to/from a PCCI event, it is required to observe the following recommendations to minimize CO₂ emissions:

- rent vehicles with low-emission combustion engines, preferably with hybrid or all-electric technology;
- plan for optimal vehicle occupancy (carpooling), avoiding single-person rentals;
- where possible, use minibus-like vehicles instead of several cars;
- plan the route so as to shorten the distance traveled.

In addition, when booking accommodation (hotels, apartments, b&b, etc.), the following recommendations should be noted:

- consider an accommodation located near the venue of the racetrack;
- consider the accommodation's commitment to the environment and the local community;
- take responsability for the environment and local community.

B. During the event

Soil, water and air protection

To avoid negative impacts on the environment, it is recommended that the Team:

- prevent spills of fuel, oils, detergents, coolant and brake fluids or other contaminants into the soil;
- place suitable containers to collect waste such as: oils, detergents, dirty cloths, etc.;













 apply every caution in order to prevent the spilling of waste liquids from vehicles into the soil;

Cleaning of Vehicles and Parts

To avoid negative impacts on the environment and reduce water consumption, the following actions are recommended to the team:

- washing of trucks, vans and vehicles should be done by minimizing the use of water;
- the cleaning products used must be certified for their minimal environmental impact (e.g., "Ecolabel") or "waterless," i.e., without the need for water consumption;
- using the water meter provided by Porsche Italia to measure the actual consumption by the team during the rounds.
- wheel cleaning should be performed with water only if the water is collected and disposed of in designated areas.

Waste management

Each team is responsible for the waste generated by its staff during each PCCI race.

Waste must be properly placed in the appropriate containers according to the type following the Municipal Regulations to which the host circuit refers. In addition, Porsche Italia provides each team with a kit of containers for separate waste collection.

Special attention must be paid to waste generated by team-specific activities, such as damaged parts of the cars, bulky packaging, brake pads, etc., and used tires must mandatorily be collected and disposed of independently by the teams. The Team is advised to avoid the use of disposable dishware; the use of dishware made of compostable and biodegradable materials is recommended.

Electrical power and energy efficiency

The electricity used by the team must be primarily supplied from the permanent power supply available at the circuit and not from portable generators.

If there is a need to use the portable generator, it must meet the following criteria:

- it must be sized to the optimum level;
- it must be placed away from personnel to avoid interference due to noise and vibrations;
- it must be kept in operation only during hours of actual use.

Any electrical equipment and lighting system used by the team should preferably be energy efficient and operated only when strictly necessary.













Promotion materials and advertising

The team and its partners/sponsors should prefer digital forms of promotion, avoiding distribution of flyers, brochures or other forms of printed materials.

Stop Cigarette butts on the ground!

Team members and all guests must use the recycling bins (unsorted waste) and cigarette receptacles available outside the Hospitality building for proper disposal of cigarette butts.

Inclusion and diversity

The team must encourage respect for diversity and ensure accessibility for people with disabilities.

Stop food waste!

Team members are required to minimize food waste by making sensible choices about the meal that is consumed at the Porsche Italia Hospitality building. The same attention should be required by the guests.

Communication and sharing of the sustainable development culture

The team is one of the most important players in the change and is therefore called upon to actively contribute to the dissemination of the culture on sustainable development issues and to raise awareness among its staff and along the chain of relationships (suppliers, sponsors, partners, guests, drivers, all other ACI Racing Weekend operators and the local community).

C. After the event

Waste management

The teams must ensure that they have placed all waste in the appropriate containers assigned to them and present at the circuit.

Social and economic impact on the territory

The teams should be aware that through the purchase of goods and services in the circuit area, they generate a positive economic impact for the local community.













Performance indicators and reporting

The teams are committed to providing the Sustainability Officer with data and information useful for performance reporting with the purpose of updating and continuously improving PCCI's sustainable management system.

Continuous improvement and feedback

The team is invited to report aspects and areas for improvement, aimed at reducing the environmental impact and improving the social impact, of both their own and PCCI-related activities, by sending an e-mail message to carreracup@porsche.it and/or by contacting the Sustainability Officer.

D. Warning System

At the care and verification of the Sustainability Officer, whenever during the weekend non-fulfilment or non-compliance is detected among the team and/or non-compliance with the recommendations of this guideline is found, a "warning" will be addressed to the team.

The warning will be sent via email to the Team Manager or Team Owner, to whom the noncompliance detected, the corrective action to be taken, and the timeline within which to implement it will be described. The Sustainability Officer will verify the implementation of the corrective action within the agreed timeframe and close the warning.
